**ORDER**

Devaki Amma Memorial College of Pharmacy, Chelembra, Malappuram vide letter read as first paper above has requested to grant No Objection Certificate to start Diploma in Pharmacy course from academic year 2014-15 with an intake of 60 seats. Their application was forwarded to Principal, Government Medical College, Kozhikode for submitting report to Government through the Director of Medical Education. Now the Director of Medical Education, Thiruvananthapuram vide paper read as second above has forwarded the inspection report recommending to grant No Objection Certificate to start first year of the course with an intake of 60 seats.

2. Government have examined the proposal in detail and are pleased to grant No Objection Certificate valid for two years to Devaki Amma Memorial College of Pharmacy, Chelembra, Malappuram to start the first year Diploma in Pharmacy course from academic year 2014-15 with an intake of 60 seats subject to the conditions that the institute shall

- a. Remit Rs.50,000/- each. (Rupees Fifty Thousand Only) as Application fee and Processing fee respectively under the following heads of account  
0210-03-101-97-01 Application fee  
0210-03-101-97-02 Processing fee
- b. Produce letter of approval from Pharmacy Council of India for starting the course from academic year 2014-15
- c. Agree to admit students on 50% merit and 50% management basis and that the merit seat students shall be admitted from the State merit list prepared by the Director of Medical Education/Director, LBS Centre for Science and Technology and the 50% management seat by Management at the rate of fee fixed by Government from time to time and subject to the conditions in the prospectus for each year.
- d. Execute an agreement and submit affidavit with Government in the Health & Family Welfare (K) Department in respect of (c) above.

- e. Produce Bank Guarantee worth Rs.5 lakhs with two year validity
- f. Report to Government and obtain Letter of Permission prior to the commencement of the course on completion of (a) to (e) above
- g. Provide all facilities as per Pharmacy Council of India Education Regulations 1991 requisite for the conduct of second year of the course on or before the end 1<sup>st</sup> year of D.Pharm course and submit report to Government for compliance verification.

3. No Objection Certificate shall be withdrawn if the institution violates any of the conditions listed above
