ORDER

- 1. Vide paper read (1), Kerala University of Health Sciences, Thrissur had invited applications from various colleges for granting Continuation of Provisional Affiliation to courses under it for the Academic Year 2023 - 24. The following Pharmacy Colleges applied for the same with required fee. The applications were processed by the University, inspection was conducted and the scrutiny committee scrutinized the inspection reports.
- 2. The deficiencies noted during inspection were intimated to the colleges mentioned in the below table and the compliance reports were submitted by the colleges. The Scrutiny Committee on verification of the compliance report recommended to grant Continuation of Provisional Affiliation to the colleges for the academic year 2023-24.

^{3.} As per the PCI circular No.14-56/2022-PCI(Approval Process 2023-24 a.s)/18889-94 dated 16.03.2023, approval has been extended to 2023-24 academic session (one year) in respect of those institutions which were approved by PCI as per approved course and intake in 2022-23.

4. The whole matter was placed before the Governing Council for appropriate decision. Vide paper read (2) above, the Governing Council resolved to grant Continuation of Provisional Affiliation to 14 Pharmacy Colleges mentioned above for the Academic Year 2023-24.

In the circumstances, Sanction is hereby accorded to grant Continuation of Provisional Affiliation to the Pharmacy Colleges mentioned in the table above for the Academic Year 2023 - 24, subject to the conditions mentioned below:

i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

ii.In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

- iii. Affiliation granted is strictly provisional and only for the academic year 2023-24. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.
- iv. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- v. The College should remit annual administration fee fixed for UG/ PG courses for the academic year 2023-24.
